HOOKUP RESERVATION POLICIES

Reservations require \$120 deposit which will be applied to your first month of residence; the balance is due upon your arrival. If you must cancel your reservation, you will be refunded \$100, provided you inform our office 30 days prior to your proposed arrival date. (This date may be extended in the case of severe illness or death in the family.)

A partial month at the end of your stay will be charged using a pro-rated formula in the Bibleville office.

It is the resident's responsibility to remember to make his monthly payment when it is due.

WEEKLY RATES: \$95.00 plus electricity DAILY RATES: \$20.00 electricity included

ELECTRIC RATES: Electricity is \$.15 per KWH. Each space has its own meter. Your meter will have been read prior to your arrival and then at the end of each month. Your bill will be placed in your mailbox and payment is due upon receipt. Please let the office know two days before you leave so that your final meter reading can be taken.

^{**}Each additional person, above two, occupying any unit will be charged the above amount. It is the responsibility of the hook-up to notify the office if this condition exists. Any visitor coming to Bibleville for a period of two weeks or less will not be charged this fee.

PLEASE DO NOT PLAN YOUR ARRIVAL OR DEPARTURE FOR SUNDAY

<u>FIRST-TIMERS PLEASE NOTE:</u> When your arrival time nears, you <u>must</u> let the office know when you plan to arrive so that we can have someone ready to assist you in parking.

ALL RV's MUST BE BACKED IN DUE TO THE LOCATION OF SEPTIC TANKS, WATER AND SEWER LINES. If you are on the 900 block, the back wheels of your unit CANNOT go back any further than the light pole with the meter on it. If you park yourself and cause any damage to septic tanks or water or sewer lines, you will be charged for repairs.

IF YOU PLAN TO ARRIVE EARLIER THAN YOUR SELECTED ARRIVAL DATE, please call the office to be sure your lot is available.

EVERY travel trailer, fifth wheel, and motor home must use a flexible hose with a cone-shaped attachment or a donut for sewer connection.

RULES AND REGULATIONS: A separate sheet of rules and regulations will be provided when you arrive. Although we try to keep these to a minimum, there must be a few rules for the benefit of all who live in the Bibleville community. Please refer to these Rules regarding the use of washers in RV units. There are three laundry rooms on the grounds for your use. ALCOHOLIC BEVERAGES AND SMOKING ARE PROHIBITED ON THE CONFERENCE GROUNDS. The Bibleville Dog Rules & Regulations are enclosed.

GATE POLICY: The security gates are always closed. As your arrival nears, call the Office to get a current gate code. A gate opener is available in the office for \$25.

SPECIAL NOTE: If you should purchase a larger unit before returning to Bibleville, please be advised that certain lots have a limit as to length.

Lots 1 through 14 and Lot 54 cannot be over 24 feet; exception will be made for 26 foot 5th wheel. Lots 47 through 53 cannot be over 27 feet; exception will be made for 29 foot 5th wheel.

If you have been assigned to one of these lots and purchase a larger unit, you need to notify us at once to see if we have a lot available that will accommodate your new unit. If you wait until you come, it is possible that we may not have a suitable site available.

STORAGE of recreational vehicles is available during the summer months for \$20 per month. By order of the Grounds and Facilities Committee, there will be a charge of \$20 to have your RV placed in storage and another \$20 to have your RV placed on a lot the next Conference season. NOTICE: If you have a 5th wheel to be stored, you will be responsible to get it moved on and off. We do not have the equipment to do this. If you wish to store your vehicle for the summer months, please make all the arrangements at the office prior to your departure. The vehicle must be identified on the outside with the number of the lot where it will be placed the following season, and a key for it must be left in the office in case of an emergency.

WINTER STORAGE: There is also a \$20 per month winter storage charge for car hauling trailers, utility trailers, travel trailers, etc.

PLEASE BE ADVISED: We are not responsible for any damage or loss to your vehicles. Be sure that you have adequate insurance.
